

Terms and Conditions for Nurawell Inc.

These Terms and Conditions ("Terms") govern your participation in the Affiliate Program and the use of the website, mobile application, and any related features (collectively referred to as the "Affiliate Program") provided by Nurawell Inc. ("we," "our," or "us"). By accessing or using our Affiliate Program, you agree to comply with and be bound by these Terms. If you do not agree to these Terms, you must not participate in our Affiliate Program.

Use of Affiliate Program

a. Eligibility

You must be at least 18 years of age to participate in our Affiliate Program. By participating in the Affiliate Program, you confirm that you are 18 years or older. If you are under 18, you are prohibited from participating in our Affiliate Program.

b. Account Registration and Account Policy

To access certain features of our Affiliate Program, including the ability to purchase affiliate packages and promote our products, you must create an account. By creating an account, you agree to provide accurate, current, and complete information, and you agree to keep this information updated.

You are solely responsible for maintaining the confidentiality of your account login information. If you believe there has been unauthorized access to your account, you must notify us immediately.

a. Affiliate Program Packages

Nurawell Inc. offers an affiliate program through which you can promote our products and services and earn commissions. As an affiliate, you are required to purchase a package that corresponds to the affiliate tier or level you wish to participate in.

b. Payment and Product Correspondence

When you purchase an affiliate package, the package price includes certain products that correspond to the affiliate tier or level you select. The products provided will be based on the amount paid for the affiliate package. For example, if you purchase a basic affiliate package, you will receive products of a specified value corresponding to that package.

Payment for the affiliate package is non-refundable, and the products provided are non-transferable and cannot be exchanged for cash.

c. Payment Methods

Payments for affiliate packages can be made through the following available payment options:

- Cash
- E-wallets (GCash, PayMaya)
- Bank Deposit
- Debit Cards
- Credit Cards

You agree to pay for the affiliate package and any associated costs as outlined when making your purchase. By choosing a payment method, you consent to the terms and conditions associated with each payment provider.

Affiliate Program Participation and Income

a. Independent Affiliate Relationship

The Affiliate Program is not an employment arrangement, nor does it establish an employer-employee relationship. By participating in the program, you are an independent affiliate. This means you are not an employee of Nurawell Inc., and your participation in the Affiliate Program does not entitle you to any employment benefits, rights, or statuses.

b. Sales-Driven Income

Your earnings as an affiliate will be determined by the sales you generate through the promotion of our products. The income you earn will depend on several factors, including but not limited to the time, effort, and ability you put into selling the products. There is no guaranteed income, and success will vary based on your performance and the results of your sales efforts.

c. Commission Structure

Commissions are earned based on the sales you generate. You will be compensated according to the affiliate package and commission structure that applies to your level in the program. Your income will fluctuate depending on how effectively you promote and sell the products.

Voluntary Monthly Subscription

a. Subscription Overview

The monthly subscription is voluntary and available to affiliates who wish to unlock additional benefits and privileges. By subscribing, you will gain access to exclusive features and rewards that are not available to non-subscribed affiliates. This subscription is available on a monthly basis and can be canceled at any time.

b. Subscription Benefits

As part of the monthly subscription, you will receive 1 bottle of Nurawell Spirulina every month. This is an added benefit to enhance your experience and wellness while participating in the affiliate program.

c. Subscription Fee

The fee for the monthly subscription will be clearly outlined during the sign-up process. The fee covers the cost of the monthly delivery of 1 bottle of Nurawell Spirulina and access to additional affiliate benefits and privileges.

d. Subscription Cancellation

You may cancel your subscription at any time by following the appropriate cancellation process within your account settings. Once canceled, you will no longer receive the monthly benefits, including the Nurawell Spirulina.

Commission Deduction and Withdrawal Fees

a. Commission Deduction

As an affiliate, you acknowledge and agree that a 10% commission deduction will be applied to your earned commissions. This deduction is part of the governing taxes and applicable charges related to the Affiliate Program.

b. Withdrawal Processing Fee

In addition to the commission deduction, a processing fee of ₱50 will be charged every time you withdraw your earned commissions. This fee covers the administrative and processing costs associated with handling commission withdrawals.

c. Acknowledgment of Fees

By participating in the Affiliate Program, you confirm that you are aware of and agree to the commission deduction and withdrawal processing fees as outlined above. These fees will be automatically applied to your earnings before any payments are made.

Acceptable Use of the Affiliate Program

You agree to use the Affiliate Program only for lawful purposes and in compliance with these Terms. Specifically, you agree not to:

Violate any local, state, or international law, rule, or regulation while participating in our Affiliate Program.

Engage in any fraudulent or deceptive activities, including unauthorized access to the Affiliate Program or another user's account.

Transmit harmful code such as viruses or malware through our Affiliate Program.

Interfere with or disrupt the operation of our Affiliate Program, servers, or networks.

Engage in vandalism, use bad language, or display any other inappropriate, abusive, or offensive behavior. Any actions that disrupt the integrity of our platform or create a negative environment for other affiliates may result in immediate termination of your account.

Termination of Participation

Nurawell Inc. reserves the right to terminate or suspend your account if you are found to have violated any of these Terms, including but not limited to the use of vandalism, offensive language, inappropriate conduct, or other behaviors that violate the company policies.

If your account is terminated for any of these violations, you will lose access to the Affiliate Program, and no refunds will be issued for any purchases made. We reserve the right to determine, in our sole discretion, what constitutes a violation of our policies.

User-Generated Content

Our Affiliate Program may allow you to submit, upload, or share content ("User Content"). By submitting User Content, you grant Nurawell Inc. a non-exclusive, worldwide, royalty-free license to use, display, modify, and distribute the content in connection with the Affiliate Program.

You are solely responsible for the User Content you submit and agree that it does not infringe upon the intellectual property rights of any third party. Nurawell Inc. reserves the right to remove any content that violates these Terms.

Prohibited Activities

In addition to the restrictions mentioned in Section 3, you are prohibited from:

Using automated systems, including "bots" or "scrapers," to access or interact with the Affiliate Program.

Collecting or harvesting personal data from other affiliates or users of the Affiliate Program without their consent.

Using the Affiliate Program for unlawful or illegal activities, including but not limited to fraud, harassment, or the distribution of harmful content.

Disclaimers and Limitation of Liability

The Affiliate Program is provided "as is" and "as available."
